



The reality of New York State's current budget for our field continues to be very disturbing. The "transformation agenda" being put forth by the government agencies that dictate how our field operates, give only lip service to the values we hold dear. But as an organization we feel morally bound to forge ahead and do everything needed to sustain the quality of life the people we serve have attained.


In December, AHRC New York City hired a new Chief Executive Officer, Marco Damiani, whose vision and leadership we are certain will assist us in moving into the future and turning our challenges into opportunities. On behalf of AHRC New York City, welcome to the 69th Annual Dinner.



Dale Hensley, a veteran Broadway actor, began volunteering at AHRC New York City last year. Aware of his background in musical theater, AHRC Volunteer Director, Karen Zuckerman, asked if he would be interested in starting a theater arts group at one of AHRC's adult programs. Dale said yes, although he had no experience in working with people with disabilities. Before too long, "AHRC on Broadway" came into being, Dale began working at several AHRC adult programs, and he had enlisted some of his Broadway friends to assist in his efforts! He also secured the Jerry Orbach Theater on 50th Street just west of Broadway as the performance venue!

Needless to say Dale's musical theater program at AHRC New York City has been an amazing success as anyone who has witnessed the pure joy engendered by the program can attest. Dale's ability to relate to people is amazing. He intuitively knows how to bring out the best in each individual he works with – he treats them with respect, asks a great deal of the individuals he works with and they respond to his requests performing in ways that surpass expectations. They learn lines, practice songs and dance moves, and support one another in their efforts. They adore Dale, running to greet him when he enters a room, they adore the other Broadway professionals Dale has brought in to assist, and they love performing!

The people AHRC serves have been allowed to shine, perhaps for the first time in their lives – and shine "on Broadway" no less. The result is joy that is truly palpable. The project has brought joy to the people who perform, the people who work with the performers, and to the lucky people in the audience who attend the performances.

We at AHRC New York City thank Dale Hensley for being who he is and we thank our lucky stars that somehow fate brought him to the AHRC family!

It is very significant that this year's recipient of the Anne Kraus Award is Joshua Hirsch. Anne Kraus's years of tireless advocacy transformed the quality of life for countless persons with intellectual and developmental disabilities. But for Josh, as he is called, and the Hirsch family, Anne was much more than a tireless advocate, Anne Kraus and her family were close family friends of the Hirsch family!

Josh joined the AHRC Board of Directors in the spring of 2004, after several conversations with the late James Murphy (father of Dinner Chair Patricia A. Murphy) and the late Michael Goldfarb. Josh's father, George, had just resigned from the AHRC New York City Board in 2004, the last founding board member to do so, and Josh felt that it was important to offer his own time and effort to an organization that had done so much to improve the life of his sister Marlene, a woman residing in an AHRC New York City residence.

During his fourteen years on the Board of Directors Josh served two 3 year terms as Treasurer and one term as Financial Secretary. Additionally he served on many standing and ad-hoc committees; Finance (Chair), Technology (Chair), Dinner (Chair), Executive, Nominating, Planning & Development, and the History & Legacy committees amongst others.

While serving as an AHRC New York City Board member he represented AHRC on the Boards of PHSI and Partnerships Inc., the two entities overseeing the operations of Partners Health Plan Inc. (PHP).
