- Skills and Achievement Commencement Credential (SACC), or
- Career Development and Occupational Studies (CDOS) Commencement Credential, or
- General Educational Development (GED), or
- Test Assessing Secondary Completion (TASC), or
- Local Diploma, or
- Regents Diploma

### Proof of High School Enrollment

If you do not have proof of a high school diploma or credential because you are still in school, submit an Enrollment Verification Letter from your current high school including all of the following information:

- Student's Full Name, and
- Name of High School, and
- Anticipated Graduation Date or Year, and
- Type of High School Diploma or Credential student is expected to earn upon graduation

The IEP is a written education plan that describes the individual learning needs and services provided to students receiving special education services in public school.
- ☐ **Psychological Evaluations**  
AHRC New York City requests a Psychological, Education/Psychoeducational, Neuropsychological, and/or Behavioral Evaluation conducted within the past three years for the purpose of eligibility review and application services. Please provide at least one of these evaluations.
- ☐ **Psychosocial Evaluation**  
AHRC New York City requests a Psychosocial Evaluation conducted within the past three years for the purpose of eligibility review and application of services.

All applicants are required to submit two recommendations written by a person from an educational institution, employer, and/or formal support from a human services agency. Recommendations must be completed using the Recommendation Form. Recommendations must be sealed in an envelope with the signature of the person writing the recommendation across the seal.
- ☐ **Medical History Self-Report**  
All applicants are required to submit a completed Medical History Self-Report.
- ☐ **Individual Authorization for Release of Protected Health Information (HIPAA-2)**  
The HIPAA-2 authorizes AHRC New York City to disclose information included on the student application and supplemental materials to the City University of New York for admission and student verification purposes.
- ☐ **Cover Sheet**  
Use this form when submitting all Supplemental Application Materials to AHRC New York City.
